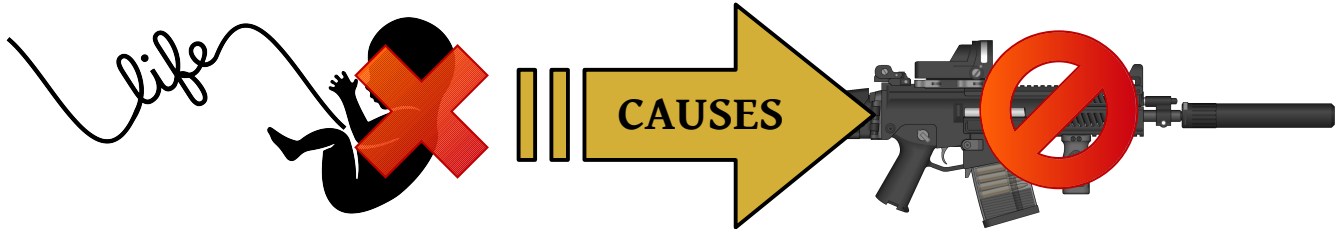

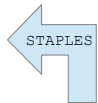

INTRODUCTION

See the next page to learn about mass murder events that killed tens of millions of people in the 20th century with the help of "gun control!"

If anyone would be well qualified to address both the proximal and deeper causes of the Holocaust and similar mass-murder campaigns, it would be the observant Jews, the Orthodox Jews.

America's last remaining right:

Gun control is a genocidal policy that was used by the worst dictators of the 20th century. Untold millions of Americans can see another Holocaust brewing here in the USA and can see clearly that the Second Amendment is our last remaining right.

But given that we are failing, we must ask whether pro-gun activism is enough on its own.

AFTER 9/11, IT WAS PERFECTLY CLEAR that the search and seizure provisions of the Fourth Amendment, with other provisions of the Bill of Rights (so pesky to totalitarians as they are), had essentially been destroyed. For almost two decades, Americans had time to either become acclimated or consider why this tragedy happened and what can be done to reverse it.

Then most of the remaining important provisions of the Bill of Rights were ended during the lockdowns—all except for the Second Amendment, of course. Canada saw a ban on their anti-Holocaust rifles during the days of the lockdowns after they had one mass shooting there.

Those who are paying attention are acutely aware that gun rights are very nearly the last rights remaining in America and are only 'hanging on by a thread.' Many are correctly motivated to make activism for gun rights their top priority, standing against a genocidal policy: so-called "gun control."

But in isolation, efforts at promoting gun rights are failing. Have we been pushing on the wrong thing?

MAYBE WE REALLY HAVE BEEN PUSHING ON THE WRONG THING. Despite high levels of support from the general public for gun rights and despite the tenacious, amazing work of a large number of pro-Second Amendment activists including Jews for the Preservation of Firearms Ownership and Gun Owners of America, we can see plainly that gun rights are very sharply on the decline in much of our nation. Yes, it's true that there is no logical reason why anyone would believe differently from JPFO and GOA if they would simply read the amazing and concise Genocide Chart (2002) by JPFO. It would seem that one-page chart would instantly end the debate for our entire nation. (See the next page for a duplication of the JPFO Genocide Chart.) But this very complete information, in and of itself, has not solved the problem. There are still well-meaning people in our country promoting gun control.

We have all heard the definition of insanity attributed to Einstein: doing the same thing over and over again while expecting a different result. This is exactly what gun rights groups today are doing. The simple fact is that everything happens by Divine Providence, not by accident. Dictatorship is not excluded from that rule. The Constitution Party here in Ory-gun (emphasis on the gun) correctly states: "Those who won't be ruled by G-d will be ruled by tyrants." This is true without exception, no matter how "libertarian" a person may be. The germ theory of disease transmission has been greatly overblown at best, but the sin theory of dictatorship is the right one. As we'll see in the upcoming pages, G-d's perfect system of justice works on the principle of *middah kineged middah*: "measure for measure."

Never has our nation been closer to starting another Holocaust. There is only one way out.

IT IS WELL-KNOWN THAT U.S. STATES HAVE THEIR OWN GUN LAWS, BUT SOME CITIES HAVE THEIR OWN REGULATIONS SEPARATE FROM THE STATE GUN LAWS. These cities have shockingly high rates of abortion. In New York City, about 60% of Black babies are aborted each year. Note: if someone believes that the lives of Black people (and people of other races) are important, maybe they should be pro-life rather than donating to an organization with two of its three founding members admitted to be “trained organizers...trained Marxists.”

And if we take an honest look at the states known for being centers of abortion tourism, we find exactly the same states which are most ready to ban all guns from the hands of the public (translation: most ready to centralize them in the hands of a government they themselves admit they don't trust).

The recent series of organized mass shootings does not compare numerically to 20th century dictatorships.

But why, then, would saving the babies save the guns? It's because we are not left on this planet without an Instruction Manual for Life and because its Author is our Judge.

Gun ownership achieves the Torah objective that the weak should be protected from the hands of the strong. Our society has become disturbingly tolerant of murder of the weakest members of mankind, the unborn, and has not protected them from the hands of doctors hired by patients.

Why would such a nation be deserving in G-d's eyes of the great and now globally rare blessing of gun ownership? For those who know saving gun ownership can save millions or billions of lives, maybe the answer to the puzzle is here in this report. Redirecting some of our efforts to the deeper cause may just unlock the full victory of today's pro-gun activism efforts, with G-d's help.

Mass murder leads to mass murder:

G-d's perfect system of justice is measure for measure.

MURDER WAS RAMPANT IN GERMAN MEDICINE BEFORE THE HOLOCAUST WAS IN FULL FORCE. Euthanasia (murder by doctors) was common and the German doctors had a reputation for killing the weak and disabled. Just seven states in the USA explicitly allow euthanasia (though both the Liverpool Pathway to comfortably, quickly lose the dying and the morphine + midazolam combination approach for coronavirus patients are almost explicitly euthanasia).

Today, there are an astonishing 73 million abortions performed each year; this statistic comes from a "pro-choice" organization. [1] For reference, that is more than 12 times the number of Jews killed in the Holocaust and it's been happening every year. This mass murder will make us deserving in G-d's eyes of another Holocaust if it is not stopped.

Some believe in a concept known as "karma." They are mistaken. But they are not terribly far from the truth. G-d really does judge favorably those who judge others favorably. And as shown in my campaign statements booklet, by voting with his dollars the American man can choose to support farmers raising pasture-based animal foods which contribute to perfect balance of beneficial atmospheric gases such as carbon dioxide and methane and are vastly more nutritious rather than paying for CAFO animals to be raised in feedlots that resemble concentration camps.

The Nazis used cattle cars to transport human beings to the work camps and death camps (which resembled CAFOs). Maybe some Europeans at the time of WWII were buying feedlot foods rather than spending somewhat more money for something more ideal. So human beings were "treated like cattle." But when the world is perfected through repentance, animals will also not be treated badly so being "treated like cattle" will no longer be considered such a degrading comment.

Here in this discussion we can see that "you reap what you sow" is actually a reality and not just a nice figure of speech. And that is exactly why we are in such great trouble with our Creator for being tolerant of abortion. The good news is that knowing the problem is half the solution! We should be thrilled and overjoyed to realize that abortion is the locked door holding back the success of the life-saving gun activism endeavors in which so many are now slaving away and racing against the clock.



A phony dialectic:

RABBI YITZCHOK DOVID SMITH HAS EXPLAINED WITH GREAT CLARITY THAT WE NEED TO BE ON THE LOOKOUT FOR PHONY DIALECTICS. One such example he has highlighted is the false vote between “the government owns your body” and “my body, my choice.” The reality, he explains, is that our bodies are entrusted to us by our Creator and there are instructions given to mankind as to how we are to take care of the human body. So this means we're not left alone to figure it out by ourselves. For those who don't know, Rabbi Smith is at the forefront of the health freedom movement and at the tip of the spear in stopping euthanasia in the state of New Jersey. I think he has plenty of experience relevant to our discussion here.

During the lockdowns and mandates related to the “coronavirus,” we saw that those who had used the slogan “my body, my choice” on the topic of abortion were promoting the goal that unvaccinated people would not be able to have employment. “My body, my choice” was certainly the opposite of their slogan when it came to vaccines. So they chose, in varying scenarios, one side of the phony dialectic or the other. The libertarian side on the abortion topic would say, “the government doesn't own your body” and it would say the same on the vaccine topic. As much as this libertarianism could sound like a rosy ideal to some, the freedom to own guns and the “freedom” to kill babies are mutually exclusive. They cannot coexist with any stability. G-d made the Law and He sets dictatorships over nations that do not follow it. Murder is a very serious crime in G-d's eyes. Why would He give the great and rare freedom of defense and security to a nation of baby-murderers?

An example was set by those who said “my body, my choice” in the debate about intentionally killing children and later claimed that the government owned the bodies of everyone when it comes to theoretically accidentally killing adults by spreading a so-called “contagious” microbe. This just goes to prove Rabbi Smith's point: both sides of that dialectic are phony. (Please see *The Contagion Myth* by the Weston A. 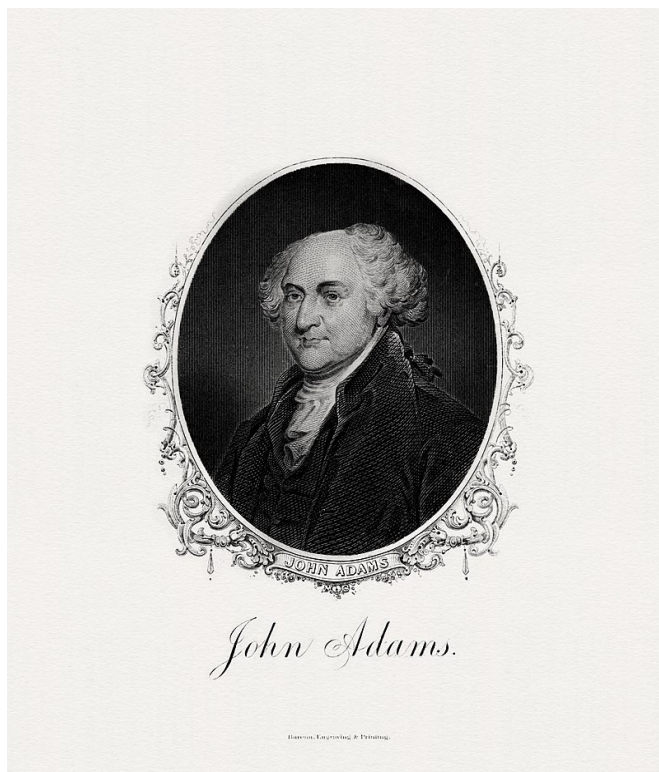

But a righteous nation—a nation that is forgiven by G-d for its past, a nation that has turned back to the one true G-d of Israel—I believe, will have...

Tolerance of abortion may well be the most important transgression in our society causing what appears to be the last remaining right in the Bill of Rights (the Second Amendment) to be lost at an accelerating pace. This is happening with great geographic precision.

IN THE PREVIOUS SECTION, WE COVERED A SLOGAN WHICH WAS IRONICALLY USED BY THOSE WHO PROMOTED ABORTION. We saw that they believed it was their body and their choice as to whether they should kill babies but that it was the government's choice as to whether someone should be allowed to have a job if unvaccinated. Here we can cover yet another slogan which is strikingly and obviously used in the service of totalitarianism.

Nothing happens by accident. Everything happens by Divine Providence. Thank G-d, I remembered this fact when I heard about a popular slogan related to abortion. This led to a startling realization. Maybe plenty of others have recognized it before, but it was startling to me: tolerance of abortion may well be the most important transgression in our society causing what appears to be the last remaining right in the Bill of Rights (the Second Amendment) to be lost at an accelerating pace. This is happening with great geographic precision. That's the theory, anyway. It's certainly a new idea to me and I wonder if anyone else will think it has any validity at all.

The slogan that kicked off my realization was "Don't say it could never happen here." This slogan was used recently to promote abortion in our country at a time when so-called "abortion rights" have been championed as the one single most important platform of many who ran for office in 2022. So first let me point out just some of the obvious problems with this thinking. "Don't say it could never happen here," most certainly, has been frequently on the lips of the religious right (of which I am, as a Noahide and a conspiracy theorist, very gladly a part) in a different context: the context of the prospect, G-d forbid, of another Holocaust. (It almost goes without saying that topic is especially relevant to me because my book manuscript now has a second title of *How to Prevent the Next Holocaust and Why It's Already Happening Right Here in America*).

So after the disastrous push to eliminate the Bill of Rights that followed 9/11 and most immediately after the disastrous push during the lockdowns related to the new breathing illness which seemed to deal the final blow—save for the Second Amendment—to the Bill of Rights, there appears to be an organized group which wanted Americans on the left to rally for their "right" to kill babies. This was actually their stated top priority. You read that correctly.

Arguably, "Don't say it could never happen here" is closely related to "Never again," another slogan meant to call attention to the Holocaust to prevent another one from happening. And recently, Holocaust survivor and medical

I did not learn about this slogan by accident. It was by Divine Providence. It highlights a huge blind spot of the left, which has been remaining, for the most part, studiously and reliably unsuspecting of any potential for repeat of government evils severe enough to resemble the worst mass-murdering regimes of the 1900s. Those who have been watching out to prevent another iteration of the Soviet gulags and the Nazi extermination camps have been slapped with Turnspeak (blaming the victim for the wrongdoing of the perpetrator) in the slanderous and now most extremely ironic use of the term "Holocaust denier."

The real truth: those who are against the very idea of anything that sounds like a "conspiracy theory" are, with their actions though not with their mouths, denying the Holocaust by assuming (consciously or not): "that could never happen here." At the same time, we can see that the same individuals are making pro-abortion activism their top campaign priority by reusing the slogan "Don't say it could never happen here" not for preventing another Holocaust, no, but for actually bringing another Holocaust one giant step closer to reality by staining our nation in G-d's eyes with the blood of children. I can almost hear the detractors who would scoff at the idea G-d judges nations. I don't think they would scoff if I said it was "bad karma" for a nation to murder millions of adults and that it could lead to another Holocaust in that nation. But if I say it's actually G-d and not karma and it's actually millions of babies rather than adults, somehow that sounds very unreasonable to some people? Why should it seem like an alien concept that G-d, the Creator, would ever pass judgment of any kind of His creations? Because the university system has worked very hard to squash this out of students.

Those rallying for abortion "rights" are able to see our nation has problems. But they are being given a surrogate cause in place of a good cause they should be involved with. It even has the same slogan: "Don't say it could never happen here."

"The voice of your brother's bloods":

Both the Jewish Bible and even the language of the oppressors point the way out.

The presently dominant political force in the USA does not wish to "lift every voice." Instead, it seeks to: minimize the voice of at least one race (White) in the name of antiracism; to cancel, de-platform, and de-bank [8] religious, conservative, pro-health-freedom individuals; and to label anti-abortion activists as terrorists. [9] Certainly the voices of the unborn are among the 'canceled' voices in cancel culture. The voices of Holocaust survivors such as Rabbi Hillel Handler and Vera Sharav are also 'canceled.' I would also argue the victims of Hitler, Mao, and Stalin would not be raising their voices, if they could, in favor of gun control and that they are also being 'canceled.' ... And unborn children don't have children of their own.

SOMETIMES, BY DIVINE PROVIDENCE, THE LANGUAGE OF THE OPPRESSORS GIVES US READY, DETAILED CLUES AS TO WHY WE ARE BEING OPPRESSED AND HOW REPENTANCE WILL END THE PROBLEM. We're investigating here why gun rights activism efforts have failed and how abortion is the national crime tightly locking up our success and preventing G-d from granting us victory.

Here in Ory-gun (emphasis on the gun), one of the most extreme of the unconstitutional gun laws ever invented in the USA (Measure 114) was said to have "passed" by narrow margin. An organization called Lift Every Voice spent over \$125,000 on working to pass this unconstitutional "law." [5] But the Jewish Bible says in Genesis 4:10 (after the murder of Cain by his brother Abel):

|| And He said, "What have you done? Hark! Your brother's blood cries out to Me from the earth... [6]

(More literally: "The voice of your brother's bloods...")
Rashi's commentary here on the plain meaning gives:

|| **Your brother's blood:** Heb. דָּמָיו, the plural form. His blood and the blood of his descendants. Another explanation: He inflicted many wounds upon him because he did not know from where his soul would depart.
— [from Sanh. 37] [6]

The plural form for blood here in Hebrew is fairly translated as "bloods" so the verse could reasonably be written in English with "your brother's bloods," the blood of his would-be descendants included.

In Ottawa, Canada in Fall 2014, a pro-life group called We Need a Law planted 100,000 flags for 400 meters in front of Parliament Hill, half of them pink and half of them blue to signify boys and girls. [7] I would say they were working to "lift every voice" of each unborn child killed that year in Canada. But maybe one of the most heinous things about the crime of abortion in G-d's eyes is that it prevents the killed from having children, making the crime worse in a way than if a full-grown mother or father had been killed. G-d sees the past, present, and future. Unborn children don't have children of their own.

"The blood of man within man":

The blessing to Noach (Noah) includes a simple reminder for mankind that abortion is murder.

We can lift the voices of the canceled unborn and find greater freedom through G-d's favor; or else the voices of mass shooting victims will be lifted in error against the Second Amendment in an emotionally charged, seemingly convincing manner, endangering all living Americans.

A would-be mass shooter isn't expected to see a No Guns Allowed sign posted and think, "Well, I was going to commit a mass murder today but it's against the law to have guns here..."

Is there a reason why children specifically have been the vehicle for pulling on the heart-strings of many? Does it point to the specific type of repentance we should focus on in our efforts to untie the knots with which our oppressors have bound us?

MY LETTER TO DUKE ENERGY ON THE CAUSE OF BOTH THE GRID ATTACKS AND THE MASS SHOOTINGS SHOWED "STRATEGIC DOMESTIC DECEPTION" IS THE NAME OF THE GAME. Clearly, few if any operations could be more emotionally charged than the murder of schoolchildren. So is there a reason on the level of the human soul as to why it is children specifically which have been used as the vehicle for pulling on the heart-strings of so many Americans? Is there a reason related to G-d's perfect system of justice, which works on the level of *middah kineged middah* (measure for measure)? Does this reason even point to the specific type of repentance we should focus on in our efforts to untie the knots with which our oppressors have bound us? Could it be possible that our nation's tolerance of abortion is very serious and very far gone, but not so far gone as to make us numb to the deaths of the born and that this warning sign can be used to show us all how vicious a crime abortion really is? We know that in G-d's eyes, a child has been murdered whether he or she gets shot or gets killed by the instruments of a callous doctor in an abortion clinic. If it is the former, that is the blood of man outside of man; if it is the latter, it is "the blood of man within man" (Gen. 9:6).

The sages of the Talmud point out that the phrase "one who sheds the blood of man through man" is more accurately translated as "one who sheds the blood of man within man." Based on this Rabbi Ishmael learns that under ordinary circumstances the killing of a fetus is considered a capital offense for all descendants of Noah, i.e., humankind. [10]

Miscellaneous:

More clues to consider.

Maybe this plural form “bloods” is a clue that whenever there is murder, there is a risk that the possible future descendants/entire family line of the victim are also being murdered. Shfichos damim (“spilling of bloods”). One of the Seven Noahide Laws is the Prohibition of Murder which is called in Hebrew “spilling of bloods.” Here we see the same plural form “bloods” as we saw previously with Cain and Abel. Maybe this plural form “bloods” is a clue that whenever there is murder, there is a risk that the possible future descendants/entire family line of the victim are also being murdered. But nowhere is this more obviously a problem than with the unborn because they have not had a chance to yet have any children of their own.

“8-12 months”: middah kineged middah. Oregon Firearms Federation (OFF) has reported that the waiting period for buying guns at shops is 8-12 months. Thank G-d, a federal judge has blocked implementation of Measure 114 so this extreme waiting period represents the existing “instant background checks”! Given that mankind is excited to know a baby is on the way, the same must be all the more true for the Creator. A pregnant mother is said to be “expectant.” So gun owners are expectant when waiting for their purchases to be transferred, most especially in a time when gun rights are under vicious attack. I would guess the warning sign built into this long waiting period is a hint to all gun owners that the right to buy guns is almost gone and the gun transfer time period (approximately the gestation period of a human being) is meant to point the way to nation-scale repentance which will restore gun rights: general repentance with a premium on pro-life efforts. There can be no doubt that G-d has waited many times for 8 or 9 or more months only to see the baby killed. It's not so uncommon for premature babies to be born one month early (at 8 months).

Open carry. A shortage of examples was provided in my assertion that there is great geographic precision in G-d's apportioning of unconstitutional gun laws. This lack of examples was in the interest of not shaming the people of certain areas of our country. But generally, some of the areas in warm climates which have a beach culture are among the most oppressed in terms of reduced gun rights. It almost goes without saying that walking around with almost zero clothing would encourage sexual promiscuity and promiscuity would itself later encourage and increase abortion. One warm part of the USA moved to ban open carry of firearms recently. Thankfully, the U.S. Supreme Court struck this down but I think the message is clear: people running around openly carrying/openly displaying what should be concealed (their body parts) are reducing the gun rights of our society and should be encouraged to live life G-d's way: with modesty (for girls this is extra important).

"Political correctness." This is not the most closely related topic to abortion but serves as another example or illustration for readers to understand the concept of limited freedom in particular arenas within G-d's world. Follow the clues!

However, he did vote in order to honor his mother (extremely important) who said he should vote. Another rabbi has suggested that a mechanism by which voting can make a real difference is by establishing some merit in Heaven for that society that is casting good votes (even if they are being counted dishonestly), resulting in good changes here on the ground. Even if the computers and/or individuals counting the earthly votes are compromised, voting for a righteous candidate is actually a good deed which should be able to have some real impact. For non-Jewish people, the underlying mechanism of such small good deeds making an impact is a kind of social contagion like this:

If gun control is accepted mathematically (just based on the number of deaths) as the most dangerous political scheme of human history and it is known that gun rights activism is woefully ineffective on its own, then whatever policy (if any) causes gun control is actually more dangerous than gun control itself. That policy is abortion. Or at least that is the thesis here in this report. What remains to be seen is whether others agree.

Based on the deaths from 2019–20, it would take 23 years for "coronavirus" to kill as many people as abortion has been killing in one year; but that calculation is based on the much lower WHO statistics on abortions per year globally. [14] As of 2016, China was aborting about 23 million babies per year, which is 10 million more per year than their government had been reporting recently. [15] Guttmacher reported 930,160 abortions in the USA from 2020 and over 1.5 million from 1991. [16] The USA's 2020 abortion deaths were almost 16 times the loss of US troops in the entire Vietnam War. [16a] If we round up that 930,160 number for 2020 and say that is around 1 million per year, that means that for every ~334 people alive today in America, one baby is being killed each year. Would that be enough to satisfy a bloodthirsty pagan idol? In 2020, about 1 in 5 pregnancies in the USA ended in abortion, says Guttmacher. "Lives unworthy of life." Today there is a prominent organization which promotes the idea of valuing the lives of Black people but has not been doing the same for babies or Black babies. Will ending abortion help loosen the grip of CPS?

"Don't talk about politics and religion." Maybe readers have noticed this has virtually been a slogan from the legacy media or at least a slogan inserted into Americans' lives. It's meant to prevent the end of the dictatorship because when we all get both politics and religion right, it's 'game over' for anyone wanting to do evil to us and they are out of a job. Support for G-d's ownership of us. The Radvaz has a commentary on Rambam, Laws of Sanhedrin 18:6. There he uses this verse to derive that a person does not own himself:

“Ghost guns.” Maybe this is a clue in the language to which we should pay attention. Maybe it means that the 'ghosts,' so to speak, of the murdered unborn are 'coming back to haunt us,' so to speak, with the great evil of anti-gun regulations of which the USA became deserving because of the blood on its 'hands,' the blood of children. And obviously, gun control is one of the most reliably genocidal policies in world history and could lead to the rest of us adults becoming 'ghosts,' so to speak, G-d forbid, through the banning of unregistered/homemade guns without serial numbers and other evil regulations (there is a saying that “registration always leads to confiscation”: it's clear that knowing where all guns are is the goal of such policies).

Bump stocks. These accessories can make semi-automatic rifles fire very quickly as an attempt at getting closer to the rate of fire of a fully automatic machine gun. They have had known accuracy problems and require a great deal of skill to operate compared to fully automatic guns but could potentially help militia groups to be somewhat more capable of protecting our country. But there is a push to ban these, too. (Note: Full auto is better; may we deserve the best weapons.) But maybe the wording is important. Let's try breaking this into two words.

I found at a very popular online dictionary site (immodest photos/won't be named here) a definition of “stock” which many have heard in sayings like, “He's of Italian stock.” In Definition 4a listed there, it means a group of descendants or family line. In Definition 4b, it instead means the original person those are all descended from. Previously, we talked about how murder, including abortion, prevents the lives of all future descendants of the murdered individual. So “stock” (Definition 4a) can mean family line. But Abel, an individual, also would have fit Definition 4b of “stock” if he had not been murdered because he would have fathered many people. That's why it was the voice of his “bloods” (plural). A stock could be fully grown or developing.

Parents hired doctors to get rid of moms' “bump stocks.” Since everything is by Divine Providence, not by accident, this wording could be the clue. Is it the central measure-for-measure reason why bump stocks are assailable today?

But I believe our nation will not suffer from the good people getting fired for doing good and never getting into high leadership positions at CIA or FBI or other alphabet agencies once the nation turns to G-d and thereby deserves to have righteous government.

The real reason why freedom is important. It would be easy for anyone to think the reason why this report is promoting freedom (including freedom in the specific area of gun rights) because people like us used to be tolerated and now in certain parts of the country we are less tolerated. After all, we all know deep down that the Founding Fathers, if alive today, would probably all be labeled "conspiracy theorists" and each of them would also probably be on a terrorist watch list maintained by subversive leadership in one of the government agencies. It's safe to say we all know deep down that the federal government has intentions of marching forward with the ridiculous premise that the religious right is the number one threat to homeland security. There have been many recent examples of news stories to that effect. While these are great reasons to promote freedom, they aren't the most foundational reason.

G-d created mankind to function with true free will. Readers know that I'm a Noahide, a non-Jew who keeps the Seven Noahide Laws, and that I learn with some Orthodox rabbis about Torah Law relevant for non-Jewish people. So one of them made a point to me recently that if a harsh dictator forced all of his nation to keep the Seven Noahide Laws, it would be a sin for him and it would be contrary to G-d's design. Our world is built in such a way so we can have real free will. But if people were constantly afraid because around every corner was a thought-reading policeman ready to whack them with a baton if they got a little out of line in their thinking, they would have no more free will than someone who avoids getting his necktie stuck in the gears of heavy machinery.

"Sin Engineering":

The dictators' attempt at preserving their own ruling power.

Medical choice is very important to the dictators, just as long as that medical choice is to kill babies.

These are efforts by G-d's enemies to engineer sin into the fabric of the dictatorship as an insurance policy against any possible future freedom. For our purposes, let's call it "sin engineering."

The electronic equivalent of book-burning is being recommended as a way to prevent the book-burning and other evils of another Nazi dictatorship.

Rabbi Yossi said: "The son of David will not come until all the souls have emptied from their spiritual abode and have been born in this physical world."

WE HAVE SEEN THAT MEDICAL CHOICE IS VERY IMPORTANT to a group that wants all American voters to believe a certain way, just as long as that medical choice is to kill babies. It appears that they believe the government should make and force every medical decision except for baby-killing or no baby-killing. That is the status today. What about tomorrow? On that trajectory, government-forced abortions would seem inevitable unless people turn to G-d with their actions and stop deserving tyranny. Forced abortions have been common in China. And a lockdown enforcement drone there said: "Please comply with covid restrictions. Control your soul's desire for freedom. Do not open the window or sing." [19] So I would suggest this lack of choice (except between baby-killing or no baby-killing) is because they want to set up a scenario where the American public has no choices available except the choice to do a sin (in this case the free will decision available to kill babies) and then push the American to choose the sin. These are efforts by G-d's enemies to engineer sin into the fabric of the dictatorship as an insurance policy against any possible future freedom so that the population is always (in their plan) deserving in G-d's eyes of more dictatorship if it continues to sin.

It was only around 10 years ago that censorship was repugnant to the USA as an indicator of communism, e.g. the well-known Chinese internet censorship controls to prevent journalism. Today, censorship is being widely recommended as the way to prevent another Nazi dictatorship. So the electronic equivalent of book-burning is being recommended as a way to prevent the book-burning and other evils of another Nazi dictatorship. You can't make this stuff up. Engineering sin into the fabric of a dictatorship to keep the dictatorship in power due to the nation being deserving of tyranny in G-d's eyes as long as sin continues is a long thing to say in one breath. So for our purposes, let's call it "sin engineering."

Abortion to delay the messiah. A Torah source could lend support to the idea of sin engineering being used in the USA in modern times. This one was recommended to me by someone:

Rabbi Yossi said: "The son of David will not come until all the souls have emptied from their spiritual abode and have been born in this physical world." [20]

The Jewish messiah (definitely a man and not G-d) will not be revealed in our world until we have reached a certain critical mass of children born on the earth. Abortion is possibly the very most direct way of preventing that.

The idea that Esav didn't want to accept the part of the Divine Prohibition of Murder which prohibited killing unborn babies is the explanation given by Rabbi Moshe Feinstein.

At its worst, the nation of Edom/Esav (Esau) is described as one "which will not respect the elderly" or "show favor to the young."

Our nation, the USA, is identified as Edom/Esav (Esau), the continuation of the Roman Empire, by the observant (Orthodox) Jews. So we'd better be sure it is a righteous 'Rome.'

So this means that the Jewish messiah (definitely a man and not G-d) will not be revealed in our world until we have reached a certain critical mass of children born on the earth. Abortion is possibly the very most direct way of preventing that. So we have to have a positive influence on everyone to stop this terrible crime.

Someone recommended another source on the topic of abortion and explained this to me: ***"The sons of Esav (Esau) did not want to accept the Torah because they could not bear the restriction on murder."*** [21] Esav is Edom/Rome.

I was also told that when abortion was coming to be legalized in the Land of Israel, Rabbi Moshe Feinstein spoke out in opposition to it, saying that the sons of Esav were opposed only parts of the Divine Prohibition of Murder: they wanted to define murder rather than follow G-d's definition. [Comment: Esav is identified as the father of Rome and is known to be a builder. Builders couldn't kill their entire populations at that time.] So the idea that Esav didn't want to accept the part of the Divine Prohibition of Murder which prohibited killing unborn babies is the explanation given by Rabbi Moshe Feinstein. [22]

At worst, the nation of Edom/Esav (Esau) is described as one "which will not respect the elderly" nor "show favor to the young." Our nation has been swiftly killing its elderly in throw-away centers called nursing homes (which don't have raw milk so I don't know how they would get started nursing someone back to health) and murdering its young at a rate of about 1 million per year. Our nation is identified as Edom/Esav (Esau), the continuation of the Roman Empire, by the observant (Orthodox) Jews. The eagle is a symbol of Rome but also on the Divine chariot. It doesn't have to symbolize evil empire as here:

⁴⁹The Lord will bring upon you a nation from afar, from the end of the earth, as the eagle swoops down, a nation whose language you will not understand,
⁵⁰a brazen nation, which will not respect the elderly, nor show favor to the young. Deuteronomy 28:49-50 [23]

Eagles care for young. At best, Esav can act as a force to promote peace, not merely avoid sin. Esav means "the deed of G-d."

Bilam's bad advice. The wicked non-Jewish prophet Bilam (Balaam) gave some very bad advice to the Midianites to turn Midianites away from a good choice in order to defeat the Jewish people. [24] The victory of the Jewish people was and is now predicated on keeping true to G-d's Instruction Manual. This is the real reason for their success and smarts (not because of a different "cranium"). After the Flood happened, the descendants

of Noah (Noah) decided that he was actually telling the truth about their commandment regarding forbidden sexual relations (Genesis 2:24) so it would be good for the nations to make a voluntary vow to not be involved in any relations outside of proper marriage. They feared a repeat of the great Flood which had punished the whole world partly on account of that sin. So the nations lived by their vow for many generations.

But when Midian wanted to ruin the Jewish people, they could not do it because of Divine favor. Along came Bilam and recommended that they send their daughters to entice the Jewish men to have relations. The king named Balak took Bilam's advice and set up a marketplace where the daughters of Midian would talk to the Jewish men. Then, just before the act of relations they were supposed to demand of each Jewish man that he perform a small service of idolatry to the idol Pe'or. This is the conspiracy that happened so long ago which shows how far people were willing to go in their desperate and hateful effort to destroy the Jewish people. Yet another modern example of 'sin engineering': entire departments of foreign intelligence services have been tasked with producing pornography to destroy American men, according to Rabbi Yitzchok Dovid Smith. When someone knows there are shards of glass in a piece of strawberry shortcake, Rabbi Smith explains, he won't bite.

Evolution. Kent Hovind ("Dr. Dino") has never lost a debate to an evolutionist. His free 7-part Creation Seminar series was very useful and informative to me before I became a Noahide. His work is excellent, except for the fact that he's unintentionally following a false religion. As stated before, anyone can just read Rabbi Tovia Singer's book and clear that one up very fast.

Below, I have included a slide from one of his presentations. It's an illustration showing that abortion is one of the branches of the evil tree of evolution. It almost goes without saying that if you believe you are an animal, then your baby is only considered an animal in your eyes, too. Henry David Thoreau was quoted in one of Dr. Dino's presentations: **"There are a thousand hacking at the branches of evil to one who is striking at the root."** That's obviously the theme behind the illustration you'll see on the next page from his free presentation. And we can easily apply it to our topic of gun control here. I think it would be fair enough to make another similar illustration with an abortion tree and say that gun control, medical tyranny, and many other evils are its branches.

Dr. Joel D. Wallach, DVM, ND, PostDoc(Path) :

ONE FORCE PUSHING EXPECTANT MOTHERS HARD in the direction of abortion is the false information given by doctors. There is also an entire industry of genetic counselors in place today. Psalm 1 warns us not to take the counsel of the unG-dly. Further, there is any number of tests (including very harmful tests like ultrasound) [24a] available to push mothers in the direction of many bad choices. Just as the germ theory of disease transmission is dying [24b], the genetic theory of disease transmission is also dying. But allopathic doctors and the monopoly that sustains them are clinging hard to the dying false belief.

Now for a short sampling of reasons not to believe in genetic fatalism. We're starting here with Dr. Wallach.

Dead Doctors Don't Lie. Anyone reading *Dead Doctors Don't Lie* by Joel D. Wallach DVM, ND, PostDoc(Path) will know that he discovered that the supposedly genetic disease cystic fibrosis can be induced in animals by giving too little of the trace mineral selenium or by administering corn oil in the food to counteract the benefits of selenium and will know how Dr. Wallach boldly crashed the NIH conference to deliver the speech he was invited (and later uninvited) to give to present his findings. He was fired from Yerkes Primate Center and blackballed so severely that word was sent to his next job (a veterinary job) in another state that they should not work with him because he was “a nut.”

Virtually by himself, he completed what would have been a multi-author textbook, *Diseases of Exotic Animals*, an enormous book which I have verified with Smithsonian really is a part of their collection as Dr. Wallach claims. (Others had left the project during its progress so he wrote their chapters, too.)

He traveled to Keshan Province, China and found out that mulberry heart disease (Keshan disease/cardiomyopathy) is caused by selenium deficiency and documented that the same kids had a high incidence of—you guessed it—cystic fibrosis.

He got his ND at NCNM in Portland, OR and treated his human patients with nutrition and supplements in a veterinary style, i.e. “You've got to go see this Doc Wallach. He treats you like a dog but you get better!” He even treated people for hemorrhoids without exams and instead gave them copper so they would actually recover. All this was alongside or after his travels to Africa to deal with elephants and rhinos and his adventures managing and once rescuing a flooded zoo with all

the animals escaping during the flood (a classic adventure story a lot like what happened with Noah). He found out that there are 60 minerals essential for all vertebrates and has taught millions through his humorous, exuberant, unmatched presentation style to take control of their own health by using the nutrients G-d provides us with.

Epigenetics. One of Doc Wallach's more recent books is called *Epigenetics: The Death of the Genetic Theory of Disease Transmission*. According to Doc Wallach, "Every birth defect you can name and ten times that many you can't [name] are caused by nutritional deficiencies." So Down's syndrome is best seen as an epigenetic disease. It could be passed on to children if certain conditions are favorable for that, but it can also be reversed up to 3 months into pregnancy, says Dr. Wallach. He says that Lauren Knievel, relative of the motorcycle stunt rider Evel Knievel, had a Down's syndrome pregnancy and was told by her doctor to abort. She instead called Dr. Wallach, who advised her to take all the essential nutrients with special emphasis on zinc, the most important for Down's syndrome and well-known to be especially important for normal DNA function. Dr. Wallach reports that she had a normal baby. *Epigenetics* is a book that covers many birth defects and shows, for instance, around pages 200–201 that sickle cell anemia (called thalassemia in white people) can be induced by selenium deficiency in white-tailed deer.

Black Gene Lies: Slave Quarter Cures. Another great book by Dr. Wallach is *Black Gene Lies: Slave Quarter Cures*. Black people are being told a big falsehood by their doctors, who are trained to say that there is a Black gene responsible for high blood pressure and other problems. Of course, high blood pressure is mainly a calcium deficiency (as is the cause for muscle cramps). So the Black population is, in Doc Wallach's terminology, being treated "like an ATM machine" by its doctors because they are being told that everything is genetic. The Amish are another population famous for their "genetic" diseases. Naturally, this fiercely independent group is probably expected to be slandered as being "inbred" or other nonsense. But in truth, they don't import their food and (until Dr. Wallach's work) generally didn't supplement so were missing a lot of those 60 essential minerals.

My conclusions. Aneurysms are prevented with copper. Type II diabetes is reversed with chromium, vanadium, and their 23 cofactors. Muscular dystrophy is prevented (and improved in adulthood) with selenium (and white muscle disease in cattle is the analog). The list goes on and on. The more one digs, the more one realizes that G-d has provided abundantly for us and we just didn't realize that we can't make a design defect claim on

our genes and sue G-d. And this is just one nutritional school of thought we've brushed the surface of. It took me about 5 years to warm up to Dr. Wallach's information because I initially had concerns he was exaggerating his claims to sell more of the supplements. After all, Youngevity is a Fortune 500 company. But I have been able to independently verify so much of what he says that I actually see zero reason to suspect any of it has been exaggerated in the slightest. So far, so good. Further, he's never made a penny off of Youngevity and willed it to his family so that he makes his living off of his books, CDs, DVDs, etc.

The Weston A. Price Foundation:

Vitamin A and blindness. WAPF has also emphasized that a study was done on pigs showing that vitamin A deficient pigs gave birth to blind pigs. Those blind pigs were given vitamin A and gave birth to normally sighted pigs. A contemporary of Dr. Price, Dr. Francis Pottenger, was able to study cat diets. He gave them raw meat and raw milk and they thrived. But when he gave cooked meat and pasteurized milk, they developed more and more frail skeletons with each generation and ultimately produced no more cats (no more reproduction).

No fillings for about 30 cavities I got around 4 years ago. Many visibly remineralized; the rest became inactive.

These are just a few examples from a nutritional school of thought which is just as vast as that of Dr. Wallach.

I would caution that the Body Ecology Diet book does recommend, just in passing, a horrible and dangerous New Age yoga/meditation practice which has been known to make people go insane (and for anyone who lost their minds to yoga or similar, I'd recommend the work of Rabbi Gutman Locks, e.g. *Coming Back to Earth*).

Growing food as in the Garden of Eden. As if those weren't enough reasons for mankind to be hopeful enough to trust G-d and not kill their children, a method of growing food from the Garden of Eden has been rediscovered. Chapter 3 of my book manuscript (free on the website) shows how this should be done and goes into detail about the documentary that publicized it.

Restoration of Vitamin C Synthesis? I'm new to this one. Vitamin C proponent Dr. Thomas Levy (not all book covers are modest so they could be painted over or otherwise covered over by wives for their husbands) maintains that hydroxytyrosol from olive leaf and olive oil can restore the genetically lost ability of mankind to produce vitamin C from glucose. (WARNING: 75-80% of olive oil was shown to be fraudulent on the shelves of USA

stores as of May 2015; vegetable oil is the deadliest thing in the food supply.) Other animals are able to make vitamin C, with guinea pigs being one well-known exception. If Dr. Levy's assertion is true, then a defect understood to be part of all mankind can be repaired or restored or at the very least compensated for. It would make sense. The olive leaf is already known to be therapeutic and the olive leaf found in the mouth of the dove in Genesis 8:11 is obviously a picture of independence from mankind and dependence on G-d because Rashi's commentary there includes an explanation of the dove's actions as if it were saying: “Let my food be as bitter as an olive in the hands of the Holy One, blessed be He, and not as sweet as honey in the hands of flesh and blood.” [25]

We should be independent of wicked and/or G-dless men for our health and not buy into genetic fatalism.

Conclusions:

Even without the hope-inspiring information above, G-d's commandments would be the same!

ALL OF THE PRECEDING OVERVIEWS OF VARIOUS NUTRITIONAL SCHOOLS OF THOUGHT show that there is much low-hanging fruit in the pioneering field of discovering nutrient deficiency diseases, most of which are being labeled genetic. Currently, most doctors are only familiar with scurvy (vitamin C), pellagra (vitamin B₃), and beriberi (vitamin B₁) and maybe a few others. The false theories behind those diseases vanished when the missing nutrients were found. At this point, there is no telling how many illnesses will be confirmed as simple nutrient deficiencies or multiple nutrient deficiencies. I mentioned just a fraction here.

However, even if this were not true, G-d's commandments still would have to be followed. In theory, even if there were not such an abundance of cures available for “genetic” diseases, we would still be required to follow G-d's commandments. But good news: Orthodox Judaism teaches that **before G-d creates the problem, He creates the solution.** So any who have been considering abortion should take a great deal of hope (and maybe some information) from this section of the report.

Mass murder leads to mass murder:

What appears to be a mere natural phenomenon is part of G-d's system of Divine justice.

I would suggest the spiritual mechanics of G-d's universe, which we cannot violate even if we want to, do not allow for absolute freedom on the part of mankind.

It is most likely that the so-called "freedom" to have an abortion and the actual freedom of gun rights are mutually exclusive in the Heavenly Court. Maybe the so-called "freedom" to have an abortion and all real medical freedoms are mutually exclusive in the Heavenly Court.

MASS MURDER LEADS TO MASS MURDER. It's not merely some cultural shift characterized by the gradual Nazification of one country or another. Instead, it's Divine justice. It is clear that G-d punished certain cities or nations for their sins in parts of the Jewish Bible. It is a basic, essential concept in Orthodox Judaism that geographic areas from one individual up to a city or up to a nation can be punished by G-d for sins. Again, it is on a geographic basis that punishments are carried out.

Oregon Family Council [26] says that in 1969, Oregon became the first state to legalize abortion; and in 1999, Oregon became the first government in the world to legalize physician-assisted suicide. Currently, there are no restrictions on abortion in Oregon and taxpayer dollars fund both abortion and assisted suicide. (And even libertarians, many of whom don't really believe in G-d, would agree at least that absolute freedom would not work).

I'd suggest the so-called "freedom" to have an abortion and all the real medical freedoms are actually mutually exclusive in the Heavenly Court. Deep down, I think we all know that decades of shamelessly maiming and sometimes killing children with vaccinations is a reason why "the chickens came home to roost" (in the style of *middah kineged middah*, "measure for measure") such that gene therapy injections were mandated in so many workplaces. And obviously we must not give up on that front. But the point of this booklet is to motivate people in the realm of anti-abortion efforts, to strongly motivate people with the incentive for the greater degrees of freedom I believe it will rapidly yield.

We tried activism efforts. We tried convincing others that so-called "gun control" is pure evil. Many activism efforts have been made. Membership organizations have been supported with dues. Very frequent legal challenges have been launched. So maybe if we all want our gun rights—which we all do—we've been pushing on the wrong thing.

Yes, a gun culture and Bill of Rights culture is a side benefit of Divine favor and achieves the Torah objective that the weak should be protected from the hands of the strong, that the people ("the civil power" to which the Oregon Constitution says the military power should be subject in its famous gun rights section) should be able to stop a thug, mass shooter, or worse. Sadly, "power to the people" is a slogan which has been used by those pushing for gun bans after at least one mass shooting.

But remember: If we save the babies, we'll save the guns.

I learned from an organization that was made to promote the Seven Noahide Laws for all mankind that a historian named Unwin found that there was an extremely remarkable statistical correlation between rampant decay of sexual law and order within a civilization and the absolute collapse and destruction of that civilization. Smaller points before some final thoughts on abortion and gun control.

If they do enough actual attacks on American soil and have the attackers claim they did it because they are anti-abortion activists, then FBI will have a seemingly legitimate reason to say that people who oppose abortion are likely to do violent things in the furtherance of that cause.

Now that we have found that keeping G-d's law is the answer to ending the dictatorship and now that we see abortion is one of the greatest sins standing in the way, a pushback from the forces of darkness seems likely. Libertarians are only partially upholding the Prohibition of Murder.

Future attacks likely. Attacks blamed on anti-abortion activists, G-d forbid, seem likely in the near future. As exemplified in the mass shootings, the FBI (along with local law enforcement) is considered by other parts of the intelligence community to be merely the unwitting clean-up crew after their operations for strategic domestic deception are carried out on American soil. (See my letter on power grid attacks and mass shootings which is a companion to this report.) I'd say their belief (e.g. belief of some within the CIA) is that if they do enough actual attacks on American soil and have the attackers claim they did it because they are anti-abortion activists, then FBI will have a seemingly legitimate reason to say that people who oppose abortion are likely to do violent things in the furtherance of that cause. Meanwhile, it is likely that FBI is prohibited from considering that some folks acting in bad faith in the intelligence community set up/organized the attacks so that FBI would then become the enforcement wing of their cruel social engineering project. Simple as that. So they do believe in preventing and prosecuting murder. However, it appears they don't believe in preventing or prosecuting murder of the most vulnerable, most helpless individuals: babies. So libertarians say they are separating religion and state while they allow abortion, G-d forbid, but they are at the same time partially upholding the Divine commandment not to murder another human being. So if they are upholding it for some people, why not for the most vulnerable and the most innocent?

This was all after years of saying “my body, my choice” was their slogan. I don't doubt this contradiction was lost on libertarians.

not seen them return. An honest assessment shows that those nations have long been full of sexual immorality, especially abortion. There is no reason those nations (and ours) cannot regain gun rights. Repentance will be the engine of that improvement because it's abundantly clear that no amount of secular gun rights activism has done it.

I acknowledge that there is a rising good trend for permit-less concealed carry in more than half the states in the USA and this may be about the only exception to the rule that gun rights are vanishing. 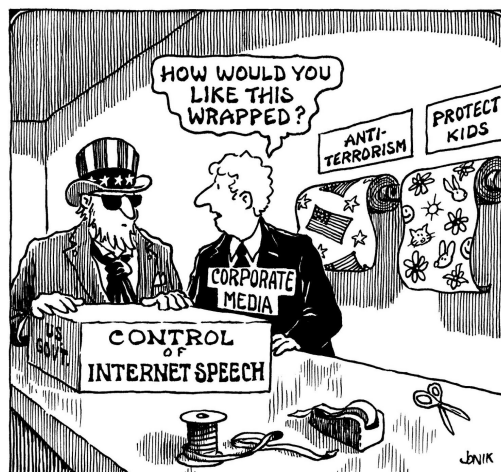
care of the plants and animals. So WAPF recommended finding things to agree on (e.g. both would agree that taking excellent care of grass-fed animals is the right thing to do). So find things you can agree on. But probably better not to call this “finding common ground” because we believe in private property and G-d's economic system of “capitalism with a conscience,” the economic system prescribed by the Torah...
